Executive Summary

Survey Background

• The City of Takoma Park, Maryland contracted with National Research Center, Inc. (NRC) to conduct a community wide resident survey. The 2007 Takoma Park Resident Survey provides residents the opportunity to rate the quality of life in the City, as well as service delivery and their satisfaction with local government. The survey also permits residents to provide feedback to government on what is working well and what is not and share their priorities for community planning and resource allocation. This is the first resident survey of Takoma Park residents.

Methods

- The 2007 Takoma Park Resident Survey was mailed to 3,000 randomly selected Takoma Park households. Of the 2,835 eligible households who received the survey, 1,057 responded to the mailed questionnaire, giving a response rate of 37%.
- Survey results were weighted so that respondent tenure and ward were represented in the proportions reflective of the list of residents provided by the City. (For more information, see the full report.) The margin of error is plus or minus three percentage points around any given percentage point, and plus or minus two points around average ratings on a 100-point scale.

Summary of Results

Generally, residents were pleased with their quality of life in Takoma Park, characteristics of the community and the quality of City services. Ratings tended to be viewed as about or higher than good on a scale of "excellent," "good," "fair," "poor." When asked if they had any additional comments, the most frequent response revolved around positive comments regarding the City. Residents reported choosing the City as their home most frequently because of its location, the great access to public transportation and the progressive nature of the community.

When comparing Takoma Park ratings to those received by other communities across the nation, Takoma Park often received higher ratings than the national average. While some ratings were similar to the norm, only 7 of the 41 available comparisons were below the norm.

A special section of the survey was set aside for the Takoma Park Police Department. The majority of survey takers felt that crime prevention programs and community-oriented policing programs were effective in deterring crime. Although contact with the police does not usually happen under the best of circumstances, the quality of that contact was viewed positively and suggestions for improvements to the department largely centered on increasing police presence.

The survey also inquired into residents' perspectives on the addition of a gymnasium to the community center. Support for the gym was high, but dropped significantly when the idea of raising taxes was part of the decision making process. Additionally, a high percent of respondents were undecided on the issue, suggesting that some public awareness campaigns may be needed.

Finally, residents completing the survey relied on printed sources of information more frequently than they attended or viewed a program or meeting. On the whole, residents felt they received the right amount of information about City activities and events and used the Takoma Park newsletter, *The Takoma Voice* and special mailings from the City most often for information.

Survey Background

Survey Purpose

The City of Takoma Park, Maryland contracted with National Research Center, Inc. (NRC) to conduct a community wide resident survey. The 2007 Takoma Park Resident Survey serves as a consumer report card for Takoma Park by providing residents the opportunity to rate the quality of life in the City, as well as the community's amenities, service delivery and their satisfaction with local government. The survey also permits residents to provide feedback to government on what is working well and what is not, and to communicate their priorities for community planning and resource allocation. This is the first iteration of the Takoma Park Resident Survey.

The focus on the quality of service delivery and the support for issues facing the City helps council, staff and the public to set priorities for budget decisions and lays the groundwork for tracking community opinions about the core responsibilities of Takoma Park government, helping to assure maximum service quality over time.

This type of survey gets at the key services that local government controls to create a quality community. It is akin to private sector customer surveys that are used regularly by many corporations to monitor where there are weaknesses in product or service delivery before customers defect to competition or before other problems from dissatisfied customers arise.

Methods

Survey Administration and Response Rate

Households received four mailings each beginning in September 2007. Completed surveys were collected over the following five weeks. The first mailing was a prenotification postcard announcing the upcoming survey. A week after the prenotification postcard was sent the first wave of the survey was sent. The second wave was sent one week after the first. The survey mailings contained a letter from the Mayor inviting the household to participate in the 2007 Resident Survey, a questionnaire in both English and Spanish, and a self-mailing envelope. The fourth and final mailing was a reminder postcard asking residents who had not yet completed the survey and returned it to do so.

About 6% of the surveys were returned because the housing unit was vacant or the postal service was unable to deliver the survey as addressed. Of the 2,835 remaining households, 1,057 completed the survey, providing a response rate of 37%.

Understanding the Results

"Don't Know" Responses and Rounding

On many of the questions in the survey, respondents could answer "don't know." The proportion of respondents giving this reply is shown in the full set of responses included in Appendix F: Survey Instrument and Complete Set of Frequencies. However, these responses have been removed from the analyses presented in the body of the report. In other words, the tables and graphs display the responses from respondents who had an opinion about a specific item. Questions where more than 20% of respondents reported "don't know" have been marked with an asterisk (*) in the body of the report.

For some questions, respondents were permitted to select multiple responses. When the total exceeds 100% in a table for a multiple response question, it is because some respondents are counted in multiple categories. When a table for a question that only permitted a single response does not total to exactly 100%, it is due to the routine practice of percentages being rounded to the nearest whole number.

Confidence Intervals

It is customary to describe the precision of estimates made from surveys by a "level of confidence" (or margin of error). The 95% confidence level for the survey is generally no greater than plus or minus three percentage points around any given percent reported for the entire sample (1,057 completed surveys). Where estimates are given for subgroups, they are less precise. For each demographic subgroup from the survey, the margin of error rises to as much as plus or minus 10% for a sample size of 97 (for race) to plus or minus 5% for 386 completed surveys (for gender).

Putting Evaluations onto a 100-point Scale

Although responses to many of the evaluative or frequency questions were made on four-or five-point scales with 1 representing the best rating, the scales had different labels (e.g., "excellent," "very effective"). To make comparisons easier, many of the results in this summary are reported on a common scale where 0 is the worst possible rating and 100 is the best possible rating. If everyone reported "excellent," then the result would be 100 on the 0-100 scale. If ratings were all "good," the result would be an average rating of 67. An average rating of 33 would be equivalent to "fair" and 0 would be "poor." The new scale can be thought of like the thermometer used to represent total giving to United Way. The higher the thermometer reading, the closer to the goal of 100 – in this case, the most positive response possible. The 95% confidence interval around a score on the 0-100 scale based on all respondents typically will be no greater than plus or minus two points on the 100-point scale.

Comparing Survey Results

An average rating of about 67 for service quality is at the "good" mark on a 100-point scale that goes from "excellent" to "poor." Few services actually receive ratings as high as 67 on the scale, and service ratings range widely. Certain kinds of services tend to be thought better of

by residents in many communities across the country. For example, police protection tends to be better received than pothole repair by residents of most American cities. Where possible, the better comparison is not from one service to another in Takoma Park, but from Takoma Park services to services like them provided by other jurisdictions. This way we can better understand if "good" is good enough for Takoma Park service evaluations.

National Normative Database

NRC has been leading the strategic use of surveys for local governments since 1991, when the principals of the company wrote the first edition of what became the classic text on citizen surveying. In *Citizen Surveys: How to do them, how to use them, what they mean*, published by ICMA, we not only articulated the principles for quality survey methods, we pioneered both the idea of benchmark data for citizen opinion and the method for gathering benchmark data. We called it, "In Search of Standards," and argued for norms. "What has been missing from a local government's analysis of its survey results is the context that school administrators can supply when they tell parents how an 80 percent score on the social studies test compares to test results from other school systems..."

NRC's database of comparative resident opinion is comprised of resident perspectives gathered in citizen surveys from approximately 500 jurisdictions whose residents evaluated local government services. Conducted with typically no fewer than 400 residents in each jurisdiction, opinions are intended to represent over 30 million Americans. NRC has innovated a method for quantitatively integrating the results of surveys that we have conducted with those that others have conducted. We have described our integration methods thoroughly in *Public Administration Review*, *Journal of Policy Analysis and Management* and in our first book on conducting and using citizen surveys. Scholars who specialize in the analysis of citizen surveys regularly have relied on our work (e.g., Kelly, J. & Swindell, D. (2002). Service quality variation across urban space: First steps towards a model of citizen satisfaction. *Journal of Urban Affairs*, 24, 271-288.; Van Ryzin, G., Muzzio, D., Immerwahr, S., Gulick, L. & Martinez, E. (2004). Drivers and consequences of citizen satisfaction: An application of the American Customer Satisfaction Index Model to New York City. *Public Administration Review*, 64, 331-341). The method described in those publications is refined regularly and statistically tested on a growing number of citizen surveys in our proprietary databases.

NRC's work on calculating national norms for resident opinions about service delivery and quality of life won the Samuel C. May award for research excellence from the Western Governmental Research Association.

The Role of Comparisons

Normative comparisons are used for benchmarking. Jurisdictions use the comparative information to help interpret their own citizen survey results, to create or revise community plans, to evaluate the success of policy or budget decisions, to measure local government performance. We don't know what is small or tall without comparing. Taking the pulse of the community has little meaning without knowing what pulse rate is too high and what is too low. When surveys of service satisfaction turn up "good" citizen evaluations, we need to know how others rate their services to understand if "good" is good enough. Furthermore, in

the absence of national or peer community comparisons, a jurisdiction is left with comparing its fire protection rating to its street maintenance rating. That comparison is unfair. Streets always lose to fire. We need to ask more important and harder questions. We need to know how residents' ratings of fire service compare to opinions about fire service in other communities.

A police department that provides the fastest and most efficient service—one that closes most of its cases, solves most of its crimes and keeps the crime rate low—still has a problem to fix if the residents in the community it intends to protect believe services are not very good compared to ratings given by residents to their own objectively "worse" departments.

The normative data can help that police department – or any City department – to understand how well citizens think it is doing. Without the comparative data, it would be like bowling in a tournament without knowing what the other teams are scoring. We recommend that citizen opinion be used in conjunction with other sources of data about budget, personnel and politics to help managers know how to respond to comparative results.

Jurisdictions in the normative database are distributed geographically across the country and range from small to large in population size. Comparisons may be made to subsets of jurisdictions (within a given region or population category). Most commonly (including in this report), comparisons are made to the entire database. Despite the differences in jurisdiction characteristics, all are in the business of providing local government services to residents. Though individual jurisdiction circumstances, resources and practices vary, the objective in every community is to provide services that are so timely, tailored and effective that residents conclude the services are of the highest quality. High ratings in any jurisdiction, like SAT scores in any teen household, bring pride and a sense of accomplishment.

Comparison of Takoma Park to the Normative Database

Normative comparisons have been provided when similar questions on the Takoma Park survey are included in NRC's database and there are at least five jurisdictions in which the question was asked, though most questions are compared to more than 100 jurisdictions. Where comparisons are available, Takoma Park results are noted as being "above" the norm, "below" the norm or "similar to" the norm. This evaluation of "above," "below" or "similar to" comes from a statistical comparison of Takoma Park's rating to the norm (the average rating from all the comparison jurisdictions where a similar question was asked). Differences of more than two points on the 100-point scale between Takoma Park's ratings and the average based on the appropriate comparisons from the database are considered "statistically significant," and thus are marked as "above" or "below" the norm. When differences between Takoma Park's ratings and the national norms are two points or less, they are marked as "similar to" the norm.

In addition to the information provided in the body of the report, more detailed tables showing the comparative data are included in Appendix C: Complete Set of Normative Comparisons. These tables show the number of jurisdictions to which Takoma Park was compared and where Takoma Park's average rating fell in the rank order of these jurisdictions' ratings.

Survey Results

Overall Quality of Life

Survey respondents were asked to rate their quality of life in Takoma Park, including overall quality of life, as a place to raise children and quality of life in neighborhood. Overall residents viewed quality of life in Takoma Park favorably with at least 2 in 10 reporting it as "excellent" and less than 5% reporting any aspect as "poor."

Scores were converted to a 100-point scale where zero equals poor and 100 equals excellent. Each aspect of quality of life received an average rating of "good" (or 67 on the 100-point scale).

Comparison to Communities Across the Nation

Average ratings given by Takoma Park residents were compared to ratings given by residents of other jurisdictions across the country. Ratings for overall quality of life and the City as a place to raise children were both rated higher than the average rating received by other jurisdictions. The rating for overall quality of life in neighborhood was similar to that of other communities. A complete set of normative comparisons can be seen in Appendix C: Complete Set of Normative Comparisons.




Figure 1: Quality of Life

Comparison by Respondent Subgroups

Respondents living in Wards 1, 2 and 3 reported higher average ratings for quality of life than respondents in Wards 4, 5 or 6. Residents who owned their home and those with higher incomes also reported higher average ratings for aspects of quality of life. A complete set of comparisons by respondent subgroups can be seen in Appendix B: Survey Results by Demographic Groups.

Community Characteristics

Characteristics of the Takoma Park community also received favorable ratings with 6 of the 11 characteristics receiving an average rating at or above "good" on the 100-point scale. Openness and acceptance towards people of diverse backgrounds received the highest average rating (74), followed by access to municipal buildings (71) and sense of community (70).

Two characteristics were rated as "good:" ease of travel by transit (69) and opportunities to attend cultural events (67). Those services not rated as "good" or above, were between "good" and "fair." Shopping opportunities (43) and the availability of affordable quality housing (37) received the lowest ratings of the group.

Comparison to Communities Across the Nation

Comparisons were available for 10 of the 11 community characteristics. Eight of the 10 were "above the norm" and just two were "below the norm." The availability of affordable quality housing received an average rating below the norm given to other communities across the nation. This may be related to the high cost of living in the DC area (higher than a lot of suburban communities in the Midwest or the South, for example).




Figure 2: Average Ratings of Quality of Community Characteristics

Reasons for Living in Takoma Park

Survey participants were provided a set of 14 reasons for living in Takoma Park and asked to select each of the reasons that applied to them. The highest number of respondents cited the closeness of the City to Washington, D.C. (66%) as their reason for living in Takoma Park. About half enjoyed the access to public transportation (53%) and that Takoma Park was a progressive community (47%). While the availability of quality affordable housing received the lowest rating from residents when rating this characteristic of the community, one-third cited it as a reason for living in Takoma Park. "Other" responses, such as "University of MD nearby by car" can be found in Appendix E: Verbatim Responses to Survey Questions.

Problems in Neighborhood

Residents were given a list of potential neighborhood problems. Neighborhoods were generally viewed favorably with only crime being considered at least a "moderate" problem by more than half of respondents and none of the potential problems being considered at least "major" problem by more than one in five survey takers.

Neighbor conflicts were considered the least problematic with three in five reporting that it was "not a problem" in their neighborhood. Aspects related to appearance were, overall, also not viewed as much of a problem with most being considered "not a problem" by at least two in five survey participants. Litter was the appearance aspect considered most problematic, but only 12% felt it was "major" or "extreme" problem.

Those neighborhood issues most concerning to residents completing the survey were crime and traffic. Crime was considered to be the most problematic with 90% reporting it as at least a "minor" problem and 62% feeling it was at least a "moderate" problem. Of the traffic related issues, speeding traffic was considered the most problematic, then traffic in general, followed by cut-through traffic.




Figure 3: Neighborhood Problems

Safety Walking Alone

In order to gauge residents' feelings of safety around Takoma Park, survey participants were asked to rate how safe or unsafe they felt walking alone around the City both during the day and after dark. Not surprisingly, residents felt safer in all locations during the day than after dark. At least two-thirds of survey participants felt "somewhat" or "very" safe at each location during the day, feeling safest in Old Town/Junction and then their neighborhood.

Over half of respondents reported feeling "somewhat" or "very" safe in Old Town/Junction and their neighborhood after dark. However, one-third or less felt safe coming from Metro station or in the University/New Hampshire/Crossroads area after dark. Feelings of safety were rated lowest for the University/New Hampshire/Crossroads; 46% of respondents reported feeling "very" unsafe there after dark.

Comparison to Communities Across the Nation

Only two of the eight locations were available for comparison. While over 90% of those surveyed reported feeling "somewhat" or "very" safe in their neighborhood during the day and 53% reported the same about their neighbor after dark, both received average ratings below those given by other communities around the country.




Figure 4: Feelings of Safety Walking Alone

Comparison by Respondent Subgroups


City Services


Overall Quality

The overall quality of City services was viewed favorably by those completing the survey; 14% thought they were "excellent," 65% thought they were "good," 19% said "fair" and just 2% felt they were "poor."

Comparison to Communities Across the Country

Overall quality of City services received an average rating of 64 (approximately "good" on the 100-point scale). This rating was above that of the average received by other jurisdictions across the country.

Individual Services

Residents receiving the survey were presented a list of 31 services provided by the City to rate as either "excellent," "good," "fair" or "poor." Overall, service quality was viewed favorably, and most services were rated as either "excellent" or "good" by a majority of those surveyed. Trash collection and recycling services were rated the highest; 42% and 37% (respectively) thought these services were "excellent." Street lighting, property maintenance code enforcement, and street repairs and maintenance received the lowest marks (16%, 21% and 19%, respectively, rated them as "poor").

Ratings were converted to the 100-point scale for ease of comparison; average ratings ranged from 76 to 45. Seven of the 31 services had average ratings of "good" or higher (67 on the 100-point scale). The remaining services were between "good" (67) and "fair" (33).

Comparisons to Communities Across the Country

Normative comparisons were available for 19 of the services: 12 were above the norm, four were similar to the norm and three were below the norm. This comparison provides a way to gauge average ratings. For example, street repairs and maintenance received the lowest average rating (45), but when comparing this rating to those from other communities, Takoma Park can see that this rating is similar all across the country. Additionally, while Takoma Park Library collections (58) was rated higher than street repairs, this rating was lower than the average reported for library collection in other jurisdictions.

Public Trust


Respondents had the opportunity to rate three public trust questions about welcoming resident involvement, the direction the City is taking and the value of services for the taxes paid. Over half of those completing the survey rated each public trust item as "good" or "excellent," with the job the City does at welcoming resident involvement receiving the highest marks.

Comparison to Communities Across the Nation

While the average rating of each public trust item was between "good" and "fair" on the 100-point scale, all were either above or similar to the norm. The job the City does welcoming resident involvement was above that of other communities, and the overall direction and the value of services for the taxes paid was similar.

City Employees

A portion of the survey was dedicated to measuring the quality of customer services provided by City employees. Just over half (54%) of those surveyed reported having contact with a City employee in the previous 12 months. These respondents were then asked a series of questions about their impression of the employee in their most recent contact. Ratings were generally positive with at least one-third rating each aspect (courtesy, knowledge, overall customer service, responsiveness and follow-up) as "excellent."

Comparisons to Communities Across the Nation

Both courtesy and knowledge were rated higher in Takoma Park than in other cities and counties around the country; overall customer service and responsiveness received ratings similar to the norm. A comparison was not available for follow-up.



In addition to rating the various aspects of customer service provided in their most recent contact, survey participants were asked to rate the customer service they received when their contact was in person, by phone or through e-mail. Not surprisingly, the more personal the contact method, the higher the customer service rating. In person contact received an average rating of 71, above "good" on the 100-point scale, and e-mail (the least personal type of contact) received the lowest rating, 57, below "good" on the 100-point scale.






Takoma Park Police Department

Several questions on the survey were dedicated to police services. Questions ranged from the effectiveness of crime prevention to the quality of contact with police.

Crime Prevention

Four out of five survey takers felt that crime prevention programs and community-oriented policing programs were "somewhat" or "very" effective in deterring crime. Sixteen percent thought it was "not very" effective and 4% reported it was "not at all" effective.



Victim of a Crime

Just 10% of survey participants reported that they or someone in their household had been the victim of a crime in the last three months. Of this 10%, 70% reported all crimes that happened to them, 8% reported some of them and 22% did not report any of the crimes.

Ratings of the effectiveness of the Takoma Park police services were compared by respondents who were victims of a crime and respondents who reported the crime to the police. Not surprisingly, residents who had not been the victim of a crime (either they or a member of their household) in the last three months felt that police services were more effective at crime deterrence than those who had been. However, there was not a difference between those who reported the crimes and those who did not.

Quality of Contact with Police Department

Four in 10 survey participants reported being in contact with the police department in the last 12 months. While contact with the police does not usually happen under the best of circumstances, the quality of that contact was viewed positively. Contact with the police department received an average rating of 70, above "good" on the 100-point scale.





Figure 14: Respondents Who had Contact with the Police Department in the Last 12 Months






Along with rating contact with the police department, participants were given a list of seven positive statements about the police and asked to rate the extent to which they agreed or disagreed with each. At least 6 in 10 respondents who had been in contact with the police department agreed with each of the statements, and 13% or fewer disagreed with any of them. Agreement was highest for "courteous in dealing with people," 83% reported "agree" or "strongly agree." "Well trained to handle problems" was agreed upon by the fewest percent of respondents, but 69% still reported "agree" or "strongly agree."

Suggestions for Improvement of Police Services

Residents receiving the survey were given the opportunity to provide suggestions for how they would improve police services in Takoma Park. Of the 1,057 completing the survey, 477 provided a suggestion; these suggestions were then categorized into thematic groups. The majority of responses centered on an increased police presence, 44% mentioned a general increase, 14% wanted more police on foot patrol, 12% suggested more bike or mounted police and 6% recommended an increase in police cars or the visibility of the patrols. "Other" responses, such as "make crime fighting safer and easier for our officers" can be found in Appendix E: Verbatim Responses to Survey Questions.




Community Project: A Gymnasium for the Community Center

The City of Takoma Park would like to add a gymnasium to the Community Center that would allow for indoor recreational activities, as well as large public events. Support for the addition of this gymnasium was high among those completing the survey. Half "strongly" supported this addition and 35% "somewhat" supported it.

Comparison by Respondent Subgroups

Support for the addition of the gym was higher among younger residents, renters and those with less income. More information can be seen in Appendix B: Survey Results by Demographic Groups.





While the City has currently raised \$1.5 million for the project, the gym will cost \$5 to \$8 million to complete, depending on the exact amenities chosen. This means that the City will need to generate extra revenue in order to complete the project.

One possible funding source would be an increase in property taxes. Support among survey participants dropped as the level of the property tax increased. While a majority (69%) did support the addition of the gym at the \$50/year rate, less than half supported the addition at any of the higher increments.

One thing to note is that around one-quarter of survey participants responded "don't know" to these questions. This suggests that a meaningful percentage of residents may need additional information before being able to make a decision on this issue.


Regardless of respondent demographics, support dropped as the tax increased. However, renters showed higher support than owners, and overall, younger residents reported higher levels of support than older residents. Takoma Park Facilities and Events

The City provides various facilities and events for the public such as the library and the community center. Residents completing the survey were asked how often they, or a member of their household, had used or attended one of these facilities or events in the last 12 months. The highest number of respondents reported using the Takoma Park Library to read or to use Wi-Fi connections; 54% reported doing this at least once. Less than half reported doing any of the remaining activities in the last 12 months. The fewest respondents reported using the New Hampshire Avenue recreation center; just 14% reported using it in the last 12 months.




Figure 20: Used or Attended a Takoma Park Facility at Least Once in the Last 12 Months

Communications Outreach

In addition to facilities and events, the City provides residents opportunities to participate in City government and ways to keep informed about what is going on in the City. The survey sought to distinguish how often residents use any of these opportunities or information sources.

The most commonly used resource was reading the City's monthly newsletter, 85% of respondents reported doing this at least once in the last 12 months and 4 in 10 reported reading it one to three times a month. Half or more of survey participants also used the recreation guide and the City's Web site at least once in the last 12 months (60% and 52%, respectively).

While only 24% reported attending a City Council meeting in person, slightly more than 29% had watched one on City TV-13. The fewest number of respondents reported watching a City Council or other programming on the City's Web site.




Figure 21: Interacted at Least Once in the Last 12 Months with City Outreach and Media




Figure 22: Used an Information Source for City Government Activities

In order to measure what information residents are getting enough of, not enough of or too much of, the survey had residents rate the level of information they received about various government functions or activities. For the most part residents were pleased with the amount of information they were receiving, with half or more reporting they received the "right amount" of information. Less than 5% of survey respondents reported they received "too much" information on any of the functions or activities. Development and construction projects were the activities that the highest number of residents felt like they received "not enough" information about.

Only a small percentage (5%) of respondents had signed up for the Takoma Park Alert System (aviso.takomapark.org). One-third of survey participants said that they would like Alerts about street closings and 2 in 10 said that they would like Alerts about building closings and cancellations for recreation programs or activities. Close to two-thirds of those surveyed indicated they would not like to receive Alerts to their e-mail or cellular phone.

Regardless of whether or not a respondent had signed up for the Alert system yet, street closings were of the most interest. Twenty-seven percent of respondents who had registered for Alerts reported that they would not like to receive Alerts.





Appendix C: Complete Set of Normative Comparisons

The following tables show more information about normative comparisons presented in the body of the report. In addition to the average rating, three numbers are provided in the table. The first is the rank assigned to Takoma Park's rating among jurisdictions where a similar question was asked. The second is the number of jurisdictions that asked a similar question. Third, the rank is expressed as a percentile to indicate its distance from the top score. This rank (5th highest out of 25 jurisdictions' results, for example) translates to a percentile (the 80th percentile in this example). A percentile indicates the percent of jurisdictions with identical or lower ratings. Therefore, a rating at the 80th percentile would mean that Takoma Park's rating is equal to or better than 80% of the ratings from other jurisdictions. Conversely, 20% of the jurisdictions where a similar question was asked had higher ratings.

Repeated from the report body is the column listing whether each was "above," "below" or "similar to" the norm.

Appendix D: Survey Methodology

Sample Selection

Approximately 3,000 households within the boundaries of Takoma Park were selected to participate in the survey using a stratified, systematic sampling method from a list of residences provided by the City. (Systematic sampling is a method that closely approximates random sampling by selecting every Nth address until the desired number of households are chosen.) The City of Takoma Park compiled the list from its rental housing database, State assessment files, street lists by ward and field checks. The list was originally compiled to compare against inaccurate 2000 Census address lists.

Addresses were divided by ward and approximately 500 houses were randomly selected from each of the six wards. To make sure that survey results could be compared by ward, the appropriate ward was ink-jetted onto each survey. This number was then data entered along with the responses to that survey. Additionally, housing units identified as being rentals were over-sampled to compensate for the tendency of residents who own their home to return surveys at a higher rate. An individual within each household was randomly selected to complete the survey using the birthday method. (The birthday method selects a person within the household by asking the "person whose birthday has most recently passed" to complete the questionnaire. The underlying assumption in this method is that day of birth has no relationship to the way people respond to surveys.)

Survey Administration and Response Rate

Households received four mailings each beginning in September 2007. Completed surveys were collected over the following five weeks. The first mailing was a prenotification postcard announcing the upcoming survey. A week after the prenotification postcard was sent the first wave of the survey was sent. The second wave was sent one week after the first. The survey mailings contained a letter from the Mayor inviting the household to participate in the 2007 Resident Survey, a questionnaire in both English and Spanish, and a self-mailing envelope. The fourth and final mailing was a reminder postcard asking residents who had not yet completed the survey and returned it to do so.

About 6% of the surveys were returned because they either had incorrect addresses or were received by vacant housing units. Of the 2,835 remaining households, 1,057 completed the survey, providing a response rate of 37%. This is a good response rate; typical response rates for a mailed resident survey range from 25% to 40%.

Reaching Non-English Speaking Residents

The cover letter and survey were mailed to residents in English and Spanish. The cover letter also included a sentence in French and Amharic instructing residents to turn the cover letter over. On the back of the cover letter was a paragraph in each of the two languages that described the contents of the packet, asked residents to find someone to help them complete the survey and provided them with a number to call where they could complete the survey over the phone with someone who speaks their language.

In total, the City received two in-language calls that were in regards to general survey questions and not to complete the survey itself. A total of 18 Spanish surveys, and 1,039 English surveys were completed.

Confidence Intervals

It is customary to describe the precision of estimates made from surveys by a "level of confidence" (or marrin of owner). The 95 percent confidence level for the survey is general.

It is customary to describe the precision of estimates made from surveys by a "level of confidence" (or margin of error). The 95 percent confidence level for the survey is generally no greater than plus or minus three percentage points around any given percent reported for the entire sample (1,057 completed surveys). Where estimates are given for subgroups, they are less precise. For each subgroup from the survey, the margin of error rises to as much as plus or minus 10% for a sample size of 97 (for race) to plus or minus 5% for 386 completed surveys (for gender).

Weighting the Data

The demographic characteristics of the survey sample were compared to those available in the sample list provided by Takoma Park and were statistically adjusted to reflect the entire list. The results of the weighting scheme are presented in the following table. The shaded variables were the ones by which survey results were weighted.

Data Analysis

Completed questionnaires were checked for accuracy by NRC staff. The data were then entered and the results analyzed by NRC using the Statistical Package for the Social Sciences (SPSS). For the most part, frequency distributions and mean ratings are presented in the body of the report. A complete set of frequencies for each survey question is presented in Appendix F: Survey Instrument and Complete Set of Frequencies.

Also included are results by demographic characteristics (Appendix B: Survey Results by Demographic Groups). Chi-square or ANOVA tests of significance were applied to these breakdowns of selected survey questions. A "p-value" of 0.05 or less indicates that there is less than a 5% probability that differences observed between groups are due to chance; or in other words, a greater than 95% probability that the differences observed in the selected categories

of our sample represent "real" differences among those populations. Where differences between subgroups are statistically significant, they are marked with grey shading in the appendices.

- Dear people: I am writing to complain about the incredibly high taxes that in irresponsible mayor and City council approve, making it difficult to afford to live in Taxakoma. The magnitude of the mistakes made by our elected officials in constructing the presumed community center, the building with a moat is outrageous. The current building is worse because of the renovations, for example it doesn't even have a kitchen which was found in the un-renovated building. A great building to play hide and seek in because the design results in an incredibly cut up building, which has to be extremely difficult to heat and cool. In fact one of the City council members and soon to be mayor is a builder who certainly didn't use his expertise in the construction. Now the City council awards themselves higher pay checks under the presumption that lower income resident would run for City council; however there is only one contested race and the mayor runs unopposed. The tax rate in Taxakoma is higher than Montgomery County; in fact it's the highest in the state of Maryland. Such high taxes limit the people who can afford to live in Taxakoma. I feel that the City council just prints money, such as this survey, they haven't met a project they wouldn't approve. How much is this survey costing? Another

example of such excessive spending is paying \$105,000 for the study of New Hampshire Avenue corridor without providing proper notification to the local residents, businesses, or even have the mayor or City council members attend the meeting. While I appreciate the diversity of the community, such diversity except for women is not reflected in the City council, so much for the big salary increase. - Having owned my house for 10+ years I am concerned about rising property taxes & our ability to move w/in the neighborhood. Would like to see some flexibility in historic area additions for those of us, who are long term residents & now priced out of buying within Takoma Park.
- Hcd is not doing its job unlicensed rental units actually submit rental roll statements but you don't even notice as can that they don't have a license. Landlords tell you in rental rolls they are exceeding allowable rent but you don't notice or don't care. Set up a database!
- Hello, I appreciate your sending me the survey so I could comment. We bought a historic home in old town Takoma Park 2.5 years ago. We paid over half a million dollars for it. We've put another \$100,000 into it. We bought the house because it was closer to work for both of us, and we thought TP seemed like a charming, liberal & well educated community, and the right place for us. 2.5 years later, we are preparing to put our house on the market and move out. If we can sell the house and not lose money, we will move out in spring of 2008. We are both college educated, have a hhi of over \$200,000 a year, and while many people are forced to remain in communities where they don't feel safe for financial reasons, fortunately we are not. I would never raise a child here. When I leave work in Bethesda, I roll my car windows up once I reach Silver Spring, so no one can stick a gun in my face and rob me. I don't walk anywhere after dark. I could easily metro to work, but I don't, because I won't walk back and forth from the metro after dark. I've seen rats the size of housecats walking down the street in front of my house. Our neighbor told our children "just to throw rocks" at the rats her kids found in their sandbox. When we bought this house, we knew TP was still a little sketchy in terms of safety, but we looked at the development and upgrading of metro accessible communities all over VA and DC, we looked at downtown Silver Spring, and we thought that would happen in TP soon as well, things would start to get better and we'd have made a good bargain. After listening to the residents of TP do nothing but argue over every single proposed development for the last 2.5 years, we realize that's not going to happen. Downtown TP is not a vibrant, inviting community. It is deserted, except for the farmer's market on Sunday. We still don't understand why residents don't see the TP metro area for what it is: seedy, run down and unsafe, and that new housing and residents and services there would correct all those problems, bring more eyes and feet on the street, new restaurants, new shops, new services. Yes the trees are beautiful-but no one's spending time in the park enjoying them, because they'd get mugged. But, we're done. We can't get out fast enough. Good luck with it.

- I believe there should be a liquir store in downtown old Takoma.
- I believe trash/recycling pickup should be twice a week other than that, I do enjoy living in Takoma Park
- I can illiterate I can't understand.
- I cannot keep reliable telephone service at my residence because of the poor quality of phone lines. I am an educator and I cannot afford to stay in MD, mainly due to the high cost of housing.
- I do not like the current leaf removal system. Huge piles of leaves remain in my neighborhood from Oct-Dec. Not safe!! I have never seen a street sweeper in my neighborhood and I've lived here 23 years!!
- I do not subscribe to cable. Therefore, I rely on word of mouth, neighborhood email lists, Takoma Gazette, Takoma Voice for Takoma Park information. Want more info re: development permits and projects before City approval.
- I don't find the City taking a look at-or paying much attention to-needs of senior residents (not those in medical financial need, but quality of life needs).
- I don't have cable therefore, can't watch TV-13. I have never heard from my ward rep, but I've never sought him/her out either.
- I don't know why my apartment building the New Hampshire towers are restricted to Comcast cable ass.
 Which very expensive. I think people should people should have freedom to chose which ever services they want.
- I don't like how much work it takes to reach a real person at the City government office. Too much bureaucracy for the small town I want.
- I enjoy "big City" services in a small town "feel". My child has gone through the schools and attends high school with some of the kids she met in kindergarton!

- Many of the City of Takoma Park employees who are the first point of contact on the telephone and/or in person have poor customer services skills. They do not acknowledge you when you enter the municipal building lobby, approach an information counter, and/or enter their office. They either ignore you or continue the conversation that they are having with a co-worker. They are curt, rude, abrupt, and uninformed. If you can get to someone in the director, manager, or supervisor level you have better luck. It is frustrating when you are unable to get a ""human being"" on the phone; vmail, vmail, vmail, is all you get. To my knowledge the addition originally planned for the municipal building was s gymnasium. However, the gym was cut from the program and offices for staff were provided and other improvements were made to the existing structure. Also, during planning, design and construction of the renovation of the municipal building, staff was unable to manage the project properly resulting in a poor design and cost overruns. I find the ""pit" in front of the building architecturally offensive, unwelcoming to the community, dangerous (especially with the emergency generator sitting there), and confusing in terms of identifying points of entry. Exterior and interior signage is poor from a vehicular perspective and when on foot. Why not just fill in the pit with water and alligators and call it a moat! The highly publicized City mulch from the fall leaf pick-up is more trouble than it is worth. The mulch is full of trash such as plastic bags. - The City council panders to vocal interest groups without consideration of the common good for the City. The council not the staff lacks leadership resulting in the majority of problems within the City.
- The City counsel has covered all areas of Takoma Park information that concerneds my needs.
- The City hall was a fiscal and architectural disaster, and continues to be.
- The City is spending too much. Needs to trim budget & reduce taxes-recreation & other feel good programs should be offered via user fee, not general taxes. Much as I like to own a BMW, I know I can only afford a Hyundai, so that's what I buy. I certain don't want to buy a BMW for the whole City!!

- The government here is not responsible about money and how it is spent. This includes not being responsible for projects such as the rec center..the mismanagement of that project was incredible.
- The historic rules should permit solar panels and other energy efficiencies! We are concerned about crime muggings have increased, as well as commercial robberies! Re-prioritize your budget before you ask me for more taxes.
- There are about a dozen tall trees in my back yard. I wish to get them cut down. There are a lot of dead limbs on trees that fall off this is very dangerous I can't afford the work that need to be done on a fix income.
- There are many house and properties in TP that are very poorly maintained. The City looks trashy because of these properties. The City should require people to maintain their property in decent condition.
- There is an affordable housing program? Have never heard this-would like more information

- We live very close to Carroll Ave., and we continue to struggle with fast and loud traffic, especially late at night. We live next to a multi-family house, which generates alot of noise and parking conflicts.
- We love living here and tell everyone we know how lucky we are to have found this slice of heaven so close to DC.
- We moved here for high quality of life & good schools/good town to raise children and it was exceeded expectations in that regard. Either City or council members should let new and/or current residents know of neighborhood email-lists etc. It is catch-as-catch-can depending on where one's home is located with some neighborhoods having well connected lists & others none. As middle-agers, it's disheartening to see home prices so high that many young families may be priced-out of Takoma park, & it is such a great place for families!
- We must make TP safe it would be really nice to have businesses other than thrift shops-downtown...how about a nice pub
- We need a auto pick up service to doctors for elderly and disabled people.
- We need a better cable system. Buildings should be required to be handicap acc doors & walkways
- We need a fenced in dog park.
- We need another cable company in Takoma Park other than Comcast. Comcast seems to be monopolizing us taking advantage
- We need bus services that are on-time and accessible after 12 midnight, most people stay out late on Fri & Sat and taxis will not pick up fares at Takoma station.
